#### ARTICLE 5 - Purpose & Powers

The purpose of the National Pathfinder Association (the "Association" for purposes of this organizing document) is strictly a non-political, military veteran organization and all assets shall be permanently dedicated for International Revenue Code (IRC) Section 501 purposes. The Association does not contemplate pecuniary gain or profit of the members thereof, and no part of the Association's net income shall inure to the benefit of any of its officers, directors, members, or any private individual.

The privileges for which the Association is organized are as follows:

- A) To educate members and the public regarding the history, present contributions and future development of Pathfinders (consistent with US security regulations), including the purchase and dedication of monuments in reverence to Pathfinders;
- B) To unite fraternally all individuals who are now, or have been a Pathfinder (to include organizing and conducting Pathfinder related reunions or gatherings);
- C) To perpetuate the Pathfinder traditions;
- D) To forward and promote the general welfare of the members and to improve by all lawful means their status and conditions;
- E) To be a source of inspiration and esprit de corps for all Pathfinders; and
- F) To provide scholarship funding to deserving family members of Pathfinders.

The powers of the Association shall be limited to all things necessary suitable, and proper for the

accomplishment of any of the purposes, objectives, privileges, or furtherance of any of the powers set forth, provided the same are consistent with all laws, regulations, or rules under which this Association is formed, including: (1) limiting its purposes to one or more of the purposes as described in International Revenue Code (IRC) Section 501 ("Permitted Purposes"); (2) establishing that this organizing document does not expressly empower the Association to engage (other than as an insubstantial part of its activities) in activities that do not further one or more of the Permitted Purposes; and (3) establishing that this organizing document does not empower the Association to (directly or indirectly) participate or intervene in any political campaign on behalf of (or in opposition to an candidate for ublic office.
